Jackie Meyer gave her **financial report**. The net worth of Section V as of April I, 2014 is \$235,228.75. There is about \$57,000 in revenues outstanding. The Finance Committee meeting was also reviewed by Jackie Meyer and Fritz Kilian. The recommendations for dues to levied in accordance with the existing policy was approved. There was discussion of Fritz Kilian's initiative for next year of a Strategic long Range Plan and how that would impact Section V's financial picture. Jackie will work with the Finance Committee Business Administrators in developing a template to be used by sport coordinators. Jackie and Ed Stores will develop the paperwork to be distributed to member schools regarding dues.

Ed Stores presented an **Executive Director's report**. He distributed a list of action items and discussion items on the NYSPHSAA agenda for the May 2, 2014 Executive Committee meeting. Each items was reviewed giving Kim Henshaw and Craig Veley direction to be followed at that meeting. Some leagues had reported that they were reviewing the policy draft and there was a request to delay approving the policy until the May meeting. This request was approved. There several changes to the original draft. Ed will compile the suggested changes and

redistribute a second draft to members of the Executive Committee and the Athletic Council.
